There will be two divisions:

- 1) Adult- any dog that is above a year old.
- 2) Puppies- any dog 2 months to a year old.

Rules & Regulations

- All dogs must be on a leash at all times until the race.
- There will be NO gambling.
- All dog owners must clean up after their pets.
- Owners must show shot records or letter from veterinarian on veterinarian letterhead.
- You may bring your dogs favorite toy to use during the race to encourage the racers.
- Dogs should be on their best behavior. If your dog attacks another dog or a human, your dog will be disqualified and you will be asked to leave immediately. NO Refunds.
- All dogs must be 2 months of age or older and have their current boosters.
- All decisions made by the judges are final and not subject to review by Owners.
- Limit one (1) dog per two (2) humans. Two owners/handlers per dog allowed in the racetrack area. One owner will place the dog in the starting area and the other will be behind the designated line at the finish line. If you need someone to help you, please let us know and we will have a staff member assist you.
- No waving blankets or other large items at the start of the race.

If you want to register more than one dog you have to fill out a form per dog.

Prizes:

1st Place-trophy and a first place dog tag.

2nd Place- second place dog tag.

3rd Place- third place dog tag.

Owner represents that he or she is the legal owner of dog listed above and desires to participate in the Wiener Dog Races to be held at the Gallipolis City Park, Gallipolis, Ohio and adjacent areas, on Monday, July 4th, 2011. As a condition to the Gallipolis City Park agreement to permit Owner to participate in the event, Owner hereby as follows:

Owners private insurance coverage available to Owner which shall provide coverage for any injuries inflicted by or to Owners dog(s). Owner further acknowledges and understands that he or she will be held responsible of any and all damage to persons or property that is caused by or related to Owners participation in the event. Gallipolis City Park shall not be responsible for any costs incurred for misbehaved animals.

Owner consents to the use of his or her name and photo and any photos of his or her dog, for publicity purposes.

Owner hereby releases and forever discharges, and waives any and all Claims (as defined below) against Gallipolis City Park, it's employees, officers, directors, shareholders, partners and affiliates (the Released Parties) that relate to the Owners dog participation in the event and agrees not to sue for those Claims. For purposes of this Agreement, "Claims" shall mean any past, present and future claims, losses, cost, expenses, liabilities, demands, or causes of legal action, and costs of defense or settlement (including, without limitation, attorneys' fees or court costs). Owner hereby agrees to indemnify and hold harmless the Released Parties against any and all Claims arising from or related to Owners participation in the event. This agreement is binding on Owners heirs and executors.

I have read the rules and waive any rights to and will not attempt to hold any party responsible if another dog bites my dog or me.
